2006 Officers Elected.....

W. Frank Wolfenbarger, longtime WFA director and supporter from Irving, Texas, was elected the new President of the Wolfenbarger Family Association in the Association's annual election of officers in the Board of Director's teleconference on January 6.

He is a Certified Public Accountant who owned his own accounting firm in the Dallas area until his retirement in 2005.

Frank headed the five-member slate of officers elected to head the organization in 2006. Fellow officers include **Buzz Evans** of Houston as Vice President, **Al Creasy** of Tryon, NC as Treasurer, **David Wolfersperger** of St. Louis as Secretary, and **Myrna Liddell** of Langley, WA as Past-President and Historian.

Who is Frank Wolfenbarger?

I would like to share a little about my Father, Frank Wolfenbarger, who has been elected President of the Wolfenbarger Family Association.

Frank was born in Missouri in 1936 to William Franklin and Maude Adams Wolfenbarger. They moved from a ranch to Irving when he was 16 years old. Dad says that was the best thing that ever happened in his life up to that date – indoor plumbing, sidewalks, and groceries actually purchased from A&P rather than being gathered from the chicken house, feed pin and garden.

Frank worked his way through college as a gas station owner, refinery worker, truck driver, oilfield roughneck, deli clerk and soldier. He received his Bachelor of Business Administration at North Texas State College, now University of North Texas. Frank began practicing as a Certified Public Accountant in the international tax field – a practice that would span over 40 years.

During this time he also was the organizer and Director of American Bank and Trust in Irving, Texas. He held various directorships in organizations in the fields of manufacturing, software, insurance, banking and real estate. Later he went back to school to get a Master of Liberal Arts at Southern Methodist University. Past presidencies include Norbuck Real Estate Properties, First Irving Corporation, Mother Ocean, Inc. and Good Shepherd Lutheran Church of Irving, Texas.

Frank sold his practice in December of 2003 and began attending Lay Minister School. Recently he graduated from Northern Texas/ Northern Louisiana Synod Lay Minister's Academy. (cont. page 4)

QUERIES.....

I am looking for any information about the daughter of **Amanda Wolfenbarger** and **John James**. On the 1900 Estill County, Kentucky census - Enumeration District 29 - Line 51 - Dwelling 92 - Family 94 we find in the household of John James, a grandson **James W. Irvine** born in April 1896. According to the census, Amanda and John had been married 31 years and she had given birth to six children. Only three of which were still living. That puts them being married in 1868/1869.

They had two living sons, **Joseph A. James** who was born in March 1876 and **Isaac "Ike" James** born in February 1882 who was living with his Uncle **Joseph Wolfenbarger** on the 1900 census. I have not been able to find this couple on the 1870 or 1880 census. They may have been in Tennessee as the census (cont page 9)

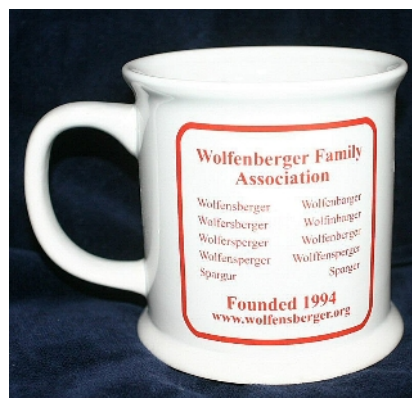

The Historian is responsible for maintaining the archival data of the WFA genealogical database and making it available to members and other interested parties. The Historian also receives additional family data and documents from members and

others, compiling this data as necessary. The Historian provides assistance to queries regarding the family history. So it is easy to see that the Historian is vital to an organization such as ours.

In addition, the Board voted to add a Vice President of International Relations. The purpose of this position is to provide a liaison between the Board and the European members of the WFA.

Any member who has any business to be considered by the Board should contact any Board member as listed elsewhere in the *Wolfensberger*.

Treasurer's Report

As the Treasurer and Membership person for WFA, I have one very unpleasant job to do each year: Drop those members who are behind in their dues.

As of the end of 2005, the total membership count of WFA was 295 members in the US and 10 members in Europe.
