Wolfenbarger Reunion Held!

Grainger County, Tennessee was the site of a celebrated Wolfenbarger family reunion on June 10, 2006. Organized by and for the descendants of Peter Wolfenbarger, the gathering remembered this Tennessee pioneer and Revolutionary War veteran who left his birthplace in Virginia and went to Tennessee with his large family after the war.

Organized by Dick Gault, the site of the reunion was a church center in the shadow of the beautiful Clinch Mountain not far from the Clinch River. It was the Clinch River valley that drew Peter from his home in Virginia, and it is around this river that a large number of his descendants lived and live still today.

Having toured our *Heimat* in the *Zuerich Oberland* I can attest that what Peter and his descendants found there was not very different geographically than that beautiful area of Switzerland his ancestors had left. Perhaps, though, here there were more snakes and fewer tall pines!

The reunion was well attended with many traveling a great distance to attend. In the Swiss traditions of thrift and community, all brought a covered dish for a communal meal.

During the course of the meal, family news was exchanged, stories and legends were told and new friendships were struck. In this convivial environment, multiple generations shared their lives with their kinfolk.

After the meal, all introduced themselves to those they did not have the opportunity to meet one-on-one, and those who brought family photographs and other family history materials reviewed these items and learned about how Peter's descendants had lived and are living.

The Civil War had a profound effect on the family. Most of Peter's descendants had supported the Confederacy. Several male descendants were killed, died or were wounded and many families were left in financial ruin by the war. After the war, the hardships of life in that area caused many to abandon East Tennessee and go West.

Among the more memorable stories recounted was that of an unfortunate soul hanged by a lynch mob for allegedly shooting a sheriff. However, the consensus of those who have investigated the history conclude that the mob hanged the wrong man and that our relation was, in fact, innocent. This will make an interesting research project for our historians!

Altogether, it was a most enjoyable occasion where young and old rekindled bonds of friendship and kinship. Dick and all the volunteers can be justly proud of the excellent job they did in organizing the reunion and in publicizing it.

I hope to share some more stories and good food with these cousins for many years to come.

Member's Notes.....

Norman Wesley Koller: Norm was born on November 26, 1916 in Florinel, West Hempfield Township, Lancaster County, Pennsylvania. He died in Liverpool, PA on June1st, 2006 at the age of 89-1/2 years.

After his birth, Norm lived with his parents and brother David on a tobacco farm. In 1918, his mother Ruth died in the flu epidemic and that event changed his destiny. His dad, William, then sold the tobacco farm to his grandfather for \$500. Following the sale, William began working for the PA Railroad in Enola. At that time, Norm and David went to live with Aunt Lizzie (William's sister), Uncle Jim and their five children one mile outside of Columbia. When he was 7-1/2 years old (1923), his father remarried and Norm and Dave were taken from Aunt Lizzie to live in Progress with their dad and stepmother, Esther. This is where he met future brother-in-law, Bob Smeltzer, and life-long friends Dot and Forry Straw.

As a boy, Norm would caddy every day at the Old Colonial Country Club(present location of the Colonial Mall.) Norm attended the Susquehanna Schools until the tenth grade. In 1929, after the stock market crash, he worked at a truck farm weeding celery for 5 cents an hour(\$2.00 per week.) The family moved to Enola where he graduated from high school. Soon after graduation, he went to Columbia to work with a cousin who was a mason contractor. After 1-1/2 years, he missed his friends in the Harrisburg area. He returned to Progress and secured employment at Hoak's Dairy where he met Janet Gabel, his first wife. A year prior to their marriage, on October 23, 1939, he was hired by the PA Railroad in Enola.

Norm and Janet were married on October 12, 1940. In 1941, they bought a farm in Liverpool, where he raised Christmas trees. Two daughters were born: Donna and Judy. During these years, he was active at Barner's Lutheran Church, where he became President of the Council. At the time of the Liverpool Lutheran parish merger, he and his family joined The Good Shepherd Lutheran Church. Norm was active in the Liverpool Lions Club of which he is a past president. He was an avid fisherman, both on the Susquehanna River and the Caloosahatchee River in Florida. Golf was another love of his life. He belonged to the Newport Club and later the Lost Creek Golf Club, where he made many friends with whom he created many memorable experiences.

WHERE IS PETER NAPOLEON WOLFENBARGER?

The WFA WorldConnect page on Rootsweb, shows Peter Wolfenbarger and his wife Elizabeth Fletcher (called Betsy) having the following children: Jacob born 1830, John born 1833, Mary (called Polly) born 25 Oct 1834, George born 1838, Frances born 1840, Henderson born 1848, Peter Napoleon born 1850, Simpson born 9 Apr 1851, Sarah born 1853 and Josiah born 1857. In adding data to this family I have found a problem. Census records show the following about this family:

Query: Can anyone shed more light on this family? I received an email from Sissy ... who wrote:

"Matilda Wolfenbarger, daughter of Abner Wolfenbarger, born 1857 Washburn, Tennessee, and Minda Margaret ... born 1859, married a Mr. Isaac Widby aka Widsby/Woodsby.

2-children...Peter (Pete) & Mary Widby/Hurst born in the early 1900's. After Matilda passed on, "Pete" stayed with Isaac, his father. Mary was left with a "Williams" family in Grainger County. She was later given to Isaac's sister and grew up with her family. Matilda had other children. Vallen Wolfenbarger, Rosa Wolfenbarger, I believe there was another daughter. I am told they went by Matilda's maiden name. Also that her children were related to the Grainger County "Williams"family. I have her death record ...died July 13, 1917 @ age 37. She was the daughter of Abner & Mindy Wolfenbarger. I have been told Abner & Mindy were cousins."



Philip Wolfenbarger - Revolutionary War Veteran

Editor's Note: In the May 2006 issue, we shared Philip's revolutionary war affidavits. In this issue, we share the rest of that research. This comes to us from Jim Kenerson, who did the research on Philip.

Transcript: Affidavit of Catharine Wolfenbarger, Pike County, OH Oct. 19, 1852.

The State of Ohio, Pike County ss:

On this 19th day of October Eighteen hundred and fifty two, personally appeared before me, a Justice of the Peace within and for said County, Catharine Wolfenbarger a resident of Beaver Township in the County of Pike, aged Seventy Eight years, who being duly sworn according to law, doth on her oath, make the following declaration, in order to obtain the benefit of the provisions made by the act of Congress, passed July 29th 1848, -

Philip Wolfenbarger, her late husband was a Pensioner of the United States for services performed by him in the Revolutionary War, and drew ninety six dollars a year, in Pike County, until the 4th September last, which was the last time he drew a pension.

The said Philip Wolfenbarger her said husband died in said County on the first day of this present October 1852, leaving this declarant his widow.

She further declares that she was married to the said Philip Wolfenbarger, in Greenbriar County Virginia, on the 23 day of May in the year Seventeen hundred and ninety one, that her husband the aforesaid Philip Wolfenbarger, died on the first day of October Eighteen hundred and fifty two = that she was not married to him prior to his leaving the service, but the marriage took place previous to the second of January, eighteen hundred viz. about time above stated. She further swears that she is now a widow, and that she has never before made

application for a Pension. She does not know whether or not there is any record of her marriage,

but supposes that there is.

On this 19th day of October 1852, before me a Justice of the Peace in and for said County, personally came, John Butcher and Pamelia Butcher, who being duly sworn according to law, make oath and say that they and each of them were well acquainted with Philip Wolfenbarger in his lifetime, and Catharine his wife - that the said Philip was a Revolutionary pensioner - that he died in said County on the first day of October instant (1852.) leaving the said Catharine his widow who has not since married, but now remains his widow. These affiants are not interested in the foregoing application.

Transcript: Affidavit of Elizabeth Taylor, Pike County, OH July 18, 1857

State of Ohio: County of Pike: ss

On this 18th day of July 1857 personally appeared before me a Justice of the Peace in and for the County of Pike in the State of Ohio, duly authorized by law to administer oaths, Elizabeth Taylor a resident of Piketon in the County of Pike and State aforesaid, aged sixty three years XXX who being duly sworn, according to law, doth on her oath, make the following declaration, in order to assert the claim of her mother Catharine Wolfenberger to the benefits of the provision made by the Act of Congress passed on the 29th July 1848, ___and also in order to assert the claim of her father Philip Wolfenberger to the benefits of the provision made by by the Act of Congress passed on May 15th 1828. That the said Philip Wolfenberger was a private under or in the Regiment of Lt Colonel William Washington and was a pensioner of the United States under the Act of March 18th 1818 on the Ohio Roll and.her mother the said Catharine Wolfenberger was a pensioner of the United States

under the Act of July 29th 1848. That she makes this Declaration for the purpose of asserting the claim of her said father Philip Wolfenberger, (he having been pensioned at ninety six dollars,) to a pension of eight dollars and thirty three cents a month or one hundred dollars a year which was a private's pay in the Cavalry of which Corps was Lieut Colonel Washington's, in which he served

and also makes this Declaration for the purpose of asserting the claim of her mother said Catharine Wolfenberger to a pension of eight dollars and thirty three cents a month or one hundred dollars per annum_____or to the difference between ninety six dollars a year which her said father and mother were pensioned at and one hundred dollars a year. And she hereby relinquishes all claim to

pension in right of said Philip Wolfenberger under the Act of March 18th 1818. That her said father Philip Wolfenberger died in the County of Pike in the State of Ohio, in the year eighteen hundred and fifty two on the first day of October and her mother said Catharine Wolfenberger died in in the said County of Pike in the year

This is the last piece of the transcription on Philip. This Philip moved to Greenbriar County, Virginia around 1789, which is now West Virginia. He was born in Lebanon County, PA and moved to the Shenandoah County, VA with his father John and mother Hannah when he was about six years old. When Philip was 19, he joined Captain Moore's Company in the Lancaster County Militia. He also served with VA troops under Major Ridley for 18 months. - Editor


