1999 Storm Damage Will Delay Start of Swiss Family Memorial

ONE DAY after Christmas 1999, a serious winter storm — one of the worst of the century — crippled most of Europe, causing wide destruction across most the continent.

Not even the foothills of the Alps, ancestral home of the Wolfensberger family, escaped unscathed. Winds ranging up to hurricane strength felled trees and destroyed the wooded uplands where the family's castle once stood near Bauma in northern Zurich canton.

As a result, the planned

memorial to the site where the family originated has been postponed to 2001, according to Peter Wolfensberger. Peter is chairman of the Bauma-based organization that negotiated with the *Verkehrsverein Bauma*, a tourist organization, and the *Zuercher Wanderwege*, a cantonal hiking organization, to build the hiking path, barbecue and picnic area on the site of the long-vanished castle.

Finished in 2001

"The damage to the area was simply too great," said

Wolfensberger. "But we expect the site will be completed next year after all the damage has been cleared."

The family memorial project was brought to reality by a special WFA committee comprised of Swiss family members and a Bauma historian.

Under the leadership of Peter Wolfensberger, chief executive of the Wolfensberger foundry in Bauma, the committee was comprised of Heini Wolfensberger, a lifetime honorary member of the WFA board, Robert Wolfensberger, his brother and Peter's father, and Max Wolfensberger, the first elected Swiss member of the WFA board. The historian, Walter Sprenger, is an authority on local history.

The Bauma memorial will include a plaque in English and German that acknowledges the historic importance of the site.

A pathway with stairs and a bridge will allow hikers to walk from the road leading to the peak of the Wolfensberg to the castle site, located a few hundred yards off the road.

The facility will resemble a similar picnic and rest area just north of Bauma on Alt Landenberg. It is part of a network of hiking paths and picnic areas built across areas of rural Switzerland.

Larry Jones to Leave WFA Presidency

LARRY JONES, who conceived and organized the Wolfensberger Family Association in 1994, has asked the WFA Board of Directors to be relieved of his responsibilities as the unpaid Association president, citing family pressures.

At the same time, a special committee of the board headed by WFA Second Vice President Myrna Liddell of Langley, Washington, is looking into a restructuring of the association that will expand and enhance its support of the organization and membership.

The recommendations of this committee will be presented to the Board of Directors at its next meeting. A future issue of *Wolfensberger* will report on the recommendations.

Under the organization's bylaws, members elect members of the Board of Directors in a Fall election. The board then elects its officers in December for the new year.

Below is the letter of resignation submitted by Larry Jones to the WFA board before its April 8 meeting.

"It was over six years ago that I began the task of organizing what turned out to be the Wolfensberger Family Association. A board of directors was selected in the Fall of 1994. Our first board meeting was held in December of 1994 and our first newsletter, *Wolfensberger*, was published in January of 1995.

We still have four directors who are charter members of our board: Bob Wolfenbarger, Myrna Liddell, Bill Spargur and me. Over the years, our Board of Directors has done a great job and given me every support. For this I shall ever be grateful.

"I have certainly enjoyed having served as your president for these years and we can all be proud of the thing we have accomplished for our family and members during this time.

I think that all of you are aware of the tremendous pressure that I have been under for many years with a wife who is critically ill. Now most of the hours of the day and night are taken with her care. That pressure has forced me to make the decision of requesting to be relieved as your president.

"I am sure that this change in administration will go smoothly, but it will take several months to get organized as your new president will like, and I am sure that your Board of Directors will make a wise choice in selecting the new president and modifying the duties of the officers and board.

I have selected Myrna Liddell as the chairperson of the committee for the job of making these changes. With Myrna on that committee is Bob Wolfenbarger, Bill Spargur and Richard "Buzz" Evans. I will also serve on this committee as a nonvoting member.

I will continue to serve until the search committee has made its selections and its recommendations are approved by the board."

After 6 months of rigorous training

In Los Angeles, They Call Him Sheriff

FUN, TRAVEL and adventure with a paycheck too! That was what I was interested in when I joined the United States Army back in 1970. For much of my adult life I worked, lived and traveled in many countries and different states within the United States.

I retired from the Army and began my current profession in Civil Service with the Air Force in Los Angeles. With the routine of the long daily drive, the routine of my work, both boys doing their own thing, and my completion of a master's degree, I needed greater challenge.

My next spare-time project was to work with the Los Angeles County Sheriff's Department as a civilian volunteer until I was accepted into the Sheriff's Academy.

My primary interest was to work with the Search and Rescue Team. Joining the department required that I become a Reserve Deputy Sheriff and complete rigorous academy training.

My training lasted almost six months and was the most difficult I have experienced since basic training in the Army. We attended class every Tuesday and Thursday night from 5:30 P.M. to 10 P.M. in Santa Clarita, an hour's drive from home. We also attended class most Saturdays and many Sundays for ten hours. This was

iso done while attending our regular jobs.

My day began then, as it does now, with my alarm ringing at 3:30 a.m. Then the carpool arrives at 4:20 a.m.. At that point, we begin a 90 minute drive to work, which starts at 6 A.M. All of this while undergoing a daily regimen of physical training.

Physical training is a key to surviving the Academy. There are six physical fitness tests — one to get in, and five more during the Academy.

That's in addition to studying for all the academic tests, including the California State test for peace officer certification. Needless to say, at graduation I was one tired person.

Personally, I find public service very rewarding. Our family is service oriented. I completed twenty years of active service in the U.S. Army, then entered Civil Service with the United States Air Force. My wife, Marta C. Spargur nee Tobinson, is also a Civil Service employee in the Air Force.

My oldest son, John, served in the U.S. Army in the Combat Engineers and now serves with the California National Guard. My youngest son is in the Army serving in the Infantry in Fort Stewart, Georgia. He recently returned from six months in Macedonia on the border with war-wracked Kosovo.

I now have peace officer status as a Reserve Deputy Sheriff and I work as a member of a Search and Rescue Team. Although I live in the desert, we also serve the adjacent mountains. I plunge down

mountains or drop from helicopters when we're unable to reach an injured or lost individual on foot.

At age 49, and after losing 56 pounds, I graduated from the Los Angeles County Sheriff's Academy as a Reserve Deputy Sheriff.

I still get my fun, travel and adventure. And I earn the grand sum of exactly one dollar a year as a member of the Los Angeles County Sheriff's Department.
