LARRY JONES SUFFERS **HEAD INJURY**


WFA founder and Past President "Larry" Jones fell victim to the bad winter weather in Oklahoma City in mid-Febraury when he apparently slipped on the icy walk, fell and severely injured himself. Larry's son, Reynold, found him inside his home with severe trauma to his head. Larry had been able to get back inside the house. He was immediately taken to the hospital where a cat-scan showed the severity of his injuries. Larry is in the critical care unit of Mercy Health Center hospital in Oklahome City.

Many years ago, Larry developed an interest in his family history and began a career of research which led him to his Wolfensberger family connection. His grandmother was Nancy Lucinda Wolfenbarger who was the daughter of William Walker Wolfenbarger. Wm. W. Wolfenbarger was born in Tennessee and settled in Missouri where he raised his family. Wm. W. was a direct descendant of Johannes and Anna Margaretha Ensminger Wolfersberger who came to America from the Alsace District of Europe about 1730.

Larry began to accumulate the family data from other descendants that he contacted by phone or visited personally. With these personal contacts, Larry began the early association that eventually became the Wolfensberger Family Association. It was certainly these personal contacts that encouraged the formation of our Association. His phone bills and travel expenses must have been quite large as he attended family reunions and other get-togethers across America. It was Larry's great interest in the family and his thoughtfulness in getting aquainted with various family members that prompted many of us to join him in the Wolfensberger Family Association.

Larry was instrumental in the drive to mark the graves of our original ancestors in Shaeferstown, PA and to begin the efforts to erect the monument dedicated several years ago on the Wolfsberg near Bauma, Switzerland. One of his greatest disappointments was his inability, due to his wife's illness, to attend the dedication ceremonies in Switzerland.

The Doctors attending to Larry feel his recovery will be prolonged and he will be unable to live alone in the future. He is unable to receive flowers in the Critical Care unit but cards and get-well notes may be sent to him at his home or to the hospital. The hospital's address is: Mercy Health Center, 4300 W. Estill County Says Goodbye

Wolfinbarger was a Clerk for nearly a

Most people called her 'Miss Maggie' and very few knew her given name was Margaret. Either way, she was a well known and well liked person in the Estill County community.


Maggie Wolfinbarger, who died last Thursday, was born Aug. 19, 1902 and reached the century mark in her life on Aug. 19, a benchmark reached only by very few people. She was a resident at the Irvine Health and Rehabilitation Center at her death.

She was born in the Wagersville community to P.A. and Susan Elizabeth Parett Wolfinbarger. Being a carpenter, her father moved the family to Irvine where he worked in his capacity for the Estill County Board of Education. When Maggie was five years old she and her four sisters and four brothers enrolled in the Irvine Graded School. At the age of nine, she was ready for the seventh grade.

Soon the family moved to South Irvine and she enrolled in the Wisemantown School District. She had to ford Station Camp Creek to get to Wisemantown, and on occasion spent the night with Flora Scott Miller and the Miller children. It was at the Miller's house she learned to pray, and developed a deep love of her religion that lasted throughout her life.

After attending school at Eastern 'Normal' (EKU) and Bowling Green Business, she worked for a year as a volunteer at Oakdale Free Methodist School in Breathitt County. She was appointed postmaster of the Ravenna Post Office and held that position for 14 years. She then worked four years in the sheriff's office for Estill County Sheriff C.T. Williams.

Her interest turned to politics and she decided to run for county clerk. She won that election in 1942 and served in that position for six terms until 1966.



Maggie once explained there were three reasons she was elected to six terms. First, she prayed daily. Second, she was honest, and finally, she always tried to treat everyone with fairness. Since she never had a car, Maggie rode to work with others. She once said that she rode to work with everyone from the garbage man to the mayor.

Maggie lived on Plum Street with her mother for many years and cared for her while she worked. After the death of her mother, she moved into an apartment on Main Street at the home of Elizabeth Witt. She later lived in her own apartment in West Irvine.

She was an active member of Irvine Free Methodist Church for 70 years. In 1969 she was commissioned a Kentucky Colonel and was inducted into the Estill Development Alliance's Hall of Honor in April, 2000.

On her 100th. birthday, she received a key to the city of Irvine from Mayor Tom Williams, and was recognized with a plaque from President George W. Bush. Her hobbies included sewing and reading.

When she was inducted into the EDA Hall of Honor, Maggie summarized her life by saying, "In every walk of life I prayed and God has guided me day by day. Down through my life I have trusted our Savior, who has never failed me."



From The President.....

Six years ago a stranger named Larry Jones phoned me to ask if I was the Wolfenbarger who visited Switzerland many years ago to meet the Wolfensberger family of Bauma. I said I was. I told him I visited Heini Wolfensberger and his father in 1962 – the first member of the American clan to visit the region.

We parted, feeling quite certain that our two families were related through a descendant who had left Switzerland some three centuries earlier. Until that visit, the best information we had about our family's origins was a hunch that it was probably German. But from where?

That fateful visit to Switzerland stirred my imagination. In a sense, I was glad that our family did not have German roots.

Would I be willing to meet, Jones asked. He was touring the country to visit family members, and he'd like to hear the story of my visit. Frankly I hadn't retold the story in more than 30 years, but for a clan whose American origins went back only to 1730 it opened a new window on our past.

Larry and I talked about our common heritage for a long time that day. He said he was planning to organize a family association. Would I help him create one? (cont. above) (cont)

The rest, as they say, is history. We worked together to found a Wolfensberger Family Association. Six years later, we have a strong, vibrant organization with roots in the United States and in Europe.

But Larry Jones is neither strong nor vibrant. He lies silent and comatose in an intensive care unit in the Mercy Hospital in Oklahoma City. A slip on ice at his home in late February brought him to the hospital in critical condition.

Larry's grandson, Dr. Kevin Jones, tells us that he spends most of time asleep or under light sedation. He is responsive to pain and touch, especially on his left side. There's little activity on his right side. His body is dealing with pneumonia on a daily basis. Recovery will be a slow, arduous process, but at least there is some change for the better.

But Larry has built a family association with a strong interest in genealogy that has built memorials in eastern Pennsylvania and northern Switzerland to the family. In each of us there is strong urge to locate our roots and understand our history. Our roots lie in the Alpine foothills of northern Switzerland, where the first Wolfensbergers settled, and in the rolling meadows of Lebanon County, Pennsylvania, where the first immigrants to this country came in 1730.

Our family has a long and remarkable history in this country, as it has in Switzerland. Larry's legacy is that we know where we come from. And we know something about our forbears who settled here before the American Revolution.

To those who know more about their family in America, we ask if you'd share your knowledge about our descendents through this newsletter. Or save it for a book of family histories we are planning for the future. Larry wanted us all to understand our rich history. He helped us learn. Now it's up to others to teach us about our family. ANOTHER LIMB OF THE TREE

WFA member Karyn Cross-Sarabia of Anderson Island, WA has provided us with photos and the history of another limb of our large family tree. Her g-g-grandfather was William A. Sparger (shown at right), son of Murlin and Bethania (Cook) Sparger of Surry County North Carolina. Murlin was the son of John W. and Sarah (Lyon) Sparger and grandson of John W. Sparger who shortened his name to Sparger from Wolfersperger and was the founder of our Sparger family.

In 1874, William A. and Mary Eliza (Fulton) Sparger moved their family to Bristol, Sullivan County TN where he became a successful farmer and industrialist. In the book *Goodspeed's History of East Tennessee*, it states that William Sparger founded the Bristol Cotton Mills in Bristol in 1875. This was only the second cotton mill to operate in the US. The mill consumed about 500 bales per year and had about 30 emplyees and operated there for many years.

Among their large family, son Winston Murlin Sparger was born in 1876. He is shown at top right in an old photograph with his first wife, Mollie (Wood) Sparger and probably their first child, Murlin W. Sparger. Mollie died in 1913 soon after the birth of their third child and Winston married Karyn's g-grandmother, Lola Bruce Smith (shown at the right). Winston and Lola's children, daughter Nellie Grace was born in 1920 and son, Yancey Wyatt in 1924. Winston is also shown in his uniform at middle right.

Nellie Grace Sparger married Orb Martin Cross and their first child, son Jerry Martin Cross (shown at right) was born in 1944. Daughter Lana Gail followed in 1947. Karyn is the daughter of Jerry Cross.


