On June 26, 2005, a celebration was held at the Hampton Inn in Yukon, Oklahome for WFA member Earl W. Spargur. Earl and his family were celebrating his 100th birthday. Earl was born in Yukon on June 27th, 1905. He had two brothers, Floyd and Carl, and a sister, Ola, who were also born in Yukon.

Earl married his childhood sweetheart, Eva Barrett, also of Yukon. They had three children, two sons and a daughter. Earl moved his family to California in 1935 and workred in the lumber business for many years.as he raised his children.

Earl purchased an apartment complex in California and was a great landlord to his tenants. In 1982, Earl moved back to Yukon in semi-retirement. He owned several houses there and again was a landlord.

The birthday celebration was attended by his daughter Nancy Kriminger, a WFA member, son Don Spargur, both of California and a number of grand children and great grand children

This great event was covered in the pages of the local newspaper, the Yukon Review, with several pictures. The party room was decorated with the Wolfensberger family flag, which was displayed in the paper's photographs.

No. 2 Joseph Wolfenberger was a son of John Wolfenberger (1730 - 1788). Joseph was b.1765 and died 1807 or 1808. His estate was settled in Shenandoah County, VA October 20, 1808 and recorded there at Court Dec. 12, 1808. The administrator of the estate was Nancy Wolfenberger. Nancy also purchased the following items at the estate sale: a small iron pot, a spinning wheel, queensware cups & saucers, kitchen dresser, and one Bible. No other Wolfenbergers are mentioned in the estate documents and Nancy's relationship to Joseph is not described. Nancy could not write, but placed her mark on the estate sale document.

WFA member Bill Spargur shared with us several news articles from various papers about members of the Spargur family. We do not know if those mentioned are from families who are members of the WFA and we have not contacted any of them. Because we are quoting newspaper articles, we felt the following was public information.

<u>From the Charlotte Sun</u> By Rachel Alexander, Staff Writer

ENGLEWOOD, Florida, August 20, 2005 -Before the first snap Friday night, the Lemon Bay
High School community took a moment of silence
to remember a player who never got to fulfill his
promise. Varsity and junior varsity football
players, their coaches and a stadium full of people
stood in a very emotional remembrance of Kelvin
Jackson, 15, who was killed last month when he
was struck by a vehicle while walking to a friend's
house. Manta Ray's 2005 football season was
dedicated in his honor, as was a page in Friday
night's program. Kelvin's No. 19 football jersey
and a copy of the program were given to his
mother, Becky Bergman, in his honor.

Wanda Spargur, a member of the Manta Ray Booster Club, made the presentation. Spargur said Kelvin was a member of the spring football team and was going to be a member of the fall 2005 varsity team. "Because of his untimely death," Spargur said, "we decided to do a dedication page in our football program, and specifically, dedicating the 2005 football program to Kelvin."

The dedication was made on behalf of the Lemon Bay Manta Ray football players, their coaches and the Manta Ray Booster Club.
"It's important that we let her know that the kids and Booster Club still think of him," Spargur said, "and we wanted her to know we still care about her family."

CHESTERTON, Indiana, September 8, 2005 *The Wizard of Oz Festival* will gather down the "yellow brick road" at a larger, central location in 2006. That's the hope organizers have for the venerable *Wizard of Oz Festival*, which will open next weekend for the last time in Chesterton. Festival organizers announced Tuesday that the event will move to the Porter County Expo Center south of Valparaiso for its 25th anniversary incarnation in 2006.

Dee Spargur, vice president of Lakeshore Festival & Events and director of the festival, said it was time for the festival to grow and Chesterton just didn't allow that. With its indoor and outdoor exhibition space, central location where all events can be held together and parking to accommodate the estimated 60,000 to 80,000 annual visitors, the expo center could accommodate that growth, Spargur said. Organizers had considered alternatives in the past 18 months, including Chesterton's Dogwood Park and Sunset Hill Park in Liberty Township, Spargur said.

# From the Des Moines Register By REGISTER STAFF WRITERS Des Moines, Iowa, March 29, 2005

Three small-plane crashes claimed six lives in Iowa in two days this week in one of the deadliest stretches of such accidents since at least 1990. Already, 2005 is above the annual average of five small-plane fatalities a year since 1990, Iowa Department of Transportation records show. The most deaths in a year was 16 in 1993. The Iowa crashes happened after flights in sunny skies with little wind and no obvious weather trouble. On Sunday, three Iowans died in a crash near West Union, Iowa.......

In the second crash Sunday, two men were killed about 6 p.m. when their plane crashed in a

cornfield, the Johnson County sheriff's office reported. The third crash, about 10 a.m. Monday, claimed the life of a 68-year-old women of Bloomfield. Her husband, the pilot, also 68, was taken to an Iowa City hospital, where his condition was unknown. They took off in their four-seat Mooney airplane from Bloomfield Municipal Airport in Davis County, headed for Arkansas. They crashed soon after. Their son is one of the owners of Heartland Aviation at the airport. "Another gentleman was outside and he saw it," said **Tony Spargur**, a partner at Heartland Aviation and a friend of the family. The crash "was near the airport, within a half-mile or a mile away," Spargur said. There was no radio call to the airport prior to the crash. "It looked like he was returning to the airport," said Spargur. "It looked like he was heading back. I went back into the shop. The other guy was watching them circle back. Then he ran in and said there had been a crash."
