How to begin

The essential tasks for the researcher of English and Welsh ancestors are to identify, from American sources, the immigrant ancestor's name, date of birth or marriage, date of immigration, and precise parish of origin. Because of the abundance of genealogical sources available in the British Isles and at the Family History Library in Salt Lake City, many researchers have an excellent chance of extending their genealogies beyond the immigrant. This guide offers a brief overview of some of the Allen County Public Library Genealogy Department's English and Welsh sources which may assist in that search

USING THE DEPARTMENT CATALOGS

There are several ways of identifying books on England and Wales in the library's online catalog at www.ACPL.Lib.in.us . For example, look under **England** or **Wales**, followed by the name of a record type. One can also search under a subject or record type followed by **England**, **Wales**, or a particular shire or parish.

The online catalog allows for flexible keyword searching, and includes most of the book and periodical collection. Dial-up access to the ACPL online catalog is available at (260) 489-7087. Do not overlook important sources available only on microfilm or microfiche. Be sure to check the microtext catalog drawer labeled "International" for a list of holdings. Also check the Family History Library Catalog at www.FamilySearch.org for information on the extensive English and Welsh holdings of that library. Researchers with further questions about the collection or catalogs should ask a librarian for assistance.

RESEARCH GUIDES

Genealogical guidebooks which focus on various aspects of English and Welsh research offer an excellent starting point for the genealogist. Most contain bibliographies for further reference.

PASSENGER LISTS & EMIGRATION RECORDS

Passenger lists and emigration records sometimes provide specific information about an immigrant's place of origin in Britain. A large number of English emigration lists have been published; many are found on the resource list titled "Passenger Lists." Passenger lists from U.S. ports, beginning in 1820, are relatively complete and available on microfilm.

GAZETTEERS & MAPS

Maps and gazetteers can help the researcher locate an ancestral town in England and Wales and determine the relevant record-keeping jurisdictions to which it belongs.

VITAL & PARISH RECORDS

The Genealogy Department houses numerous published extracts of English church records, the bulk of which date before 1750. Other works offer guidance in finding vital record sources in England and Wales. Check the online catalog under the specific name of a parish or shire. Most of these extracts are included in the *International Genealogical Index* at www.FamilySearch.org.

WILLS & PROBATE RECORDS

Many of England's earliest wills have been either indexed or abstracted, and published. They can offer an important record of family relationships, especially where parish registers are lacking.

DIRECTORIES & CENSUS RECORDS

With the exception of the 1881 census, the Genealogy Department has very few census records for the British Isles. Directories often serve as valuable census substitutes since they provide names and addresses, usually in cities and towns, for specific years.

Because many English censuses are not indexed and persons are listed by street address, directories of names and addresses make useful guides for census research.

COUNTY HISTORIES

The *Victoria History of the Counties of England*, begun in 1900, covers many English counties. Highly regarded for their detail and scholarship, the volumes often contain material on local families. Check the online catalog under **Victoria History of...** In addition, the department houses numerous other local histories for England and Wales. Check the catalog under the name of the place.

PEERAGE, GENTRY& HERALDRY

Many pedigrees of English and Welsh nobility and gentry have appeared in print. Some are more reliable than others; a sample of notable works is listed below. Records of herald's visitations date from the medieval period and contain numerous pedigrees, although they are sometimes inaccurate. If interested in coats of arms for a particular surname, consult the *Heraldry Index*, /Gc 929.6 H412/volumes 1 and 2.
